

End User License, Warranty, and Safety Notices

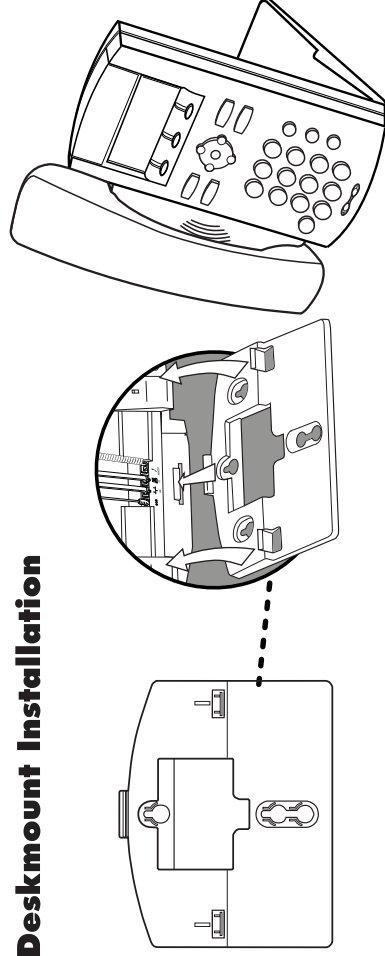

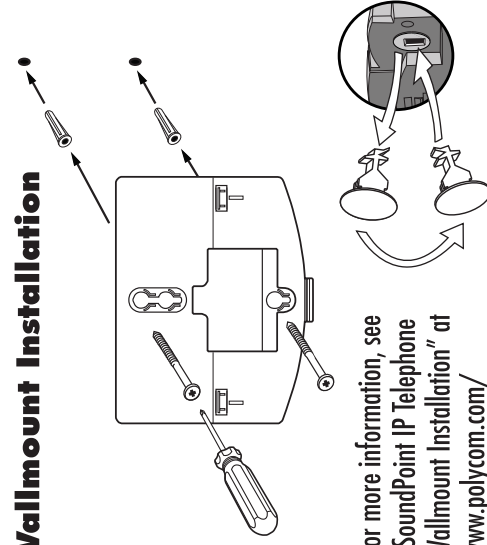


Deskmount Installation
